Application are invited from suitable and interested candidates for being considered for appointment to the post of President, State Consumer Disputes Redressal Commission (SCDRC), Chhattisgarh Raipur under Consumer Protection Act, 2019 and Rules framed there under.

#### 2. Total vacancy of President - 01(One)

#### 3. QUALIFICATION

As per Rule 3(1) of Consumer Protection (Qualification for appointment, method of recruitment, procedure of appointment, term of office, resignation and removal of the President and members of the State Commission and District Commission) Rules, 2020 notified by Department of Food, Civil Supply and Consumer Protection Department vide notification dated 08.02.2021,

A person should be who is, or has been, a Judge of the High Court.

#### 4. DISQUALIFICATIONS

As per rule 5 of Consumer Protection (Qualification for appointment, method of recruitment, procedure of appointment, term of office, resignation and removal of the President and members of the State Commission and District Commission) Rules, 2020 notified by Department of Food, Civil Supply and Consumer Protection Department vide notification dated 08.02.2021,

A person shall be disqualified for appointment as President of a State Commission if he/she -

- a) has been convicted and sentenced to imprisonment for an offence which involves moral turpitude; or
- b) has been adjudged to be insolvent; or
- c) is of unsound mind and stands so declared by a competent court; or

- d) has been removed or dismissed from the service of the State Government or Central Government or a body corporate owned or controlled by such Government; or
- e) has, in opinion of the State Government, such financial or other interest as is likely to prejudicially affect his functions as the President.

#### 5. PROCEDURE OF APPOINTMENT

Appointment will be made by the State Government on the recommendation of selection Committee Constituted under Rule 6 (1) of Consumer Protection (Qualification for appointment, method of recruitment, procedure of appointment, term of office, resignation and removal of the President and members of the State Commission and District Commission) Rules, 2020 notified by Department of Food, Civil Supply and Consumer Protection Department vide notification dated 08.02.2021,

The President of the State Commission shall be appointed by the State Government on the recommendation of a Selection Committee, consisting of the following persons, namely:-

(a) Chief Justice of the High Court or any Judge of the High Court nominate by him

- Chairperson;

(b) Secretary in charge of Consumer Affairs of the State Government

- Member;

(c) Nominee of the Chief Secretary of the State

- Member.

#### 6. TERMS OF OFFICE

As per Rule 10 of Consumer Protection (Qualification for appointment, method of recruitment, procedure of appointment, term of office, resignation and removal of the President and members of the State Commission and District Commission) Rules, 2020 notified by Department of Food, Civil Supply and Consumer Protection Department vide notification dated 08.02.2021, President, State Commission shall hold office for a term of four years or up to the age of sixty-five-years, whichever is earlier and shall be eligible for reappointment for another term of four years subject to the age limit of sixty five years, and such reappointment is made on the basis of the recommendation of the Selection Committee.

- 7. The applicant has to send self attested copies of following documents along with the resume:
  - i) Documentary proof about age,
  - ii) Copy of NOC from employer, if serving
  - iii) Recent passport size photo.
  - iv) Any other relevant Certificate.
  - v) In case of retired applicants, date of superannuation will be necessary from the last employer.

#### 8. REMOVAL

As per Rule 8 of Consumer Protection (Qualification for appointment, method of recruitment, procedure of appointment, term of office, resignation and removal of the President and members of the State Commission and District Commission) Rules, 2020 notified by Department of Food, Civil Supply and Consumer Protection Department vide notification dated 08.02.2021, The State Government shall remove from office any President, who:-

- (a) has been adjudged as an insolvent; or
- (b) has been convicted of an offence which involves moral turpitude; or
- (c) has become physically or mentally incapable of acting as such member; or
- (d) has acquired such financial or other interest as is likely to affect prejudicially his functions as a member; or
- (e) has so abused his position as to render his continuance in office prejudicial to public interest:

Provided that where a President is proposed to be removed on any ground specified in clauses (c) to (e) of the Consumer Protection ( Qualification for appointment, method of recruitment, procedure of appointment, term of office, resignation and removal of the President and members of the State Commission and District Commission) Rules, 2020, notified by Department of Food, Civil Supply and Consumer Protection Department vide notification dated 08.02.2021, the President shall be informed of the charges against him and given an opportunity of being heard in respect of those charges.

### 9. SALARY, ALLOWNCES AND TERMS AND CONDITIONS

Salary and allowances and conditions of service of President, State Commission will be as per Chhattisgarh Consumer Protection (Salary, Allowances and Conditions of Service of President and Members of State Commission and District Commission) Rules, 2020 as notified by the State Government vide notification dt. 08.02.2021.

#### 10. OATHS OF OFFICE AND SECRECY

As per Rule 6(13) of Consumer Protection (Qualification for appointment, method of recruitment, procedure of appointment, term of office, resignation and removal of the President and members of the State Commission and District Commission) Rules, 2020 notified by Department of Food, Civil Supply and Consumer Protection Department vide notification dated 08.02.2021, before appointment, the selected candidate shall furnish an undertaking that he/she does not and will not have any such financial or other interest as is likely to affect prejudicially his functions as a President.

- 11. As per Rule 6(12) of Consumer Protection (Qualification for appointment, method of recruitment, procedure of appointment, term of office, resignation and removal of the President and members of the State Commission and District Commission) Rules, 2020 notified by Department of Food, Civil Supply and Consumer Protection Department vide notification dated 08.02.2021, every appointment of a President shall be subject to submission of a certificate of physical fitness duly signed by a Civil Surgeon or District Medical Officer.
- 12. A bank draft of Rs 1000 (Rupees one thousand) issued by a Nationalized bank in favor of the **Registrar, Chhattisgarh State Consumer Disputes Redressal Commission**, payable at Raipur will be attached with the duly filled application by the candidates.
- 13. Persons who are selected for appointment would have to resign/take voluntary retirement from the post being held at that time, before taking up his appointment.
- 14. The persons selected for appointment will have to join within 30 days from the date of issue of appointment order.
- 15. The Department of Food, Civil Supply and Consumer Protection Department, Government of Chhattisgarh reserves the right to cancel the advertisement at any time without assigning any reasons.
- 16.
